To: PHS's Shareholders,

I. For Domestic Shareholders (Institutional and Individual):

1. PHS will carry out automatic depository for Shareholders who have securities trading accounts at PHS.
2. Based on VSD's regulation, Shareholders who have ID card expired or passport registered have to change personal information to valid ID card (passport is not allowed to register at VSD).

Therefore, we kindly request the Shareholder who have ID card expired arrange your time to go to PHS for changing ID card information before **April 14th, 2018**. After April 14th, 2018, any Shareholders do not change yet ID card information procedures, PHS will automatically apply current information and the change of ID card information will be applied by VSD's regulation.

3. Any Shareholder do not have securities trading account at PHS, please contact PHS's Branches/ Trading Offices to open account. The list of Shareholders open securities trading accounts at PHS will be finalized at **4:30 pm on April 14th, 2018**.

To open securities trading account at PHS, please visit website: www.phs.vn and view the list of Branches/Trading Offices of PHS. ID card for Individual Shareholder or certified copy of business registration certificate/establishment decision for Institutional Shareholder are required for opening account.

4. After getting VSD's approval for PHS's shares depository registration, PHS will automatically deposit PHS share for Shareholders into securities trading account opened at PHS.
5. In case Shareholders do not want to deposit automatically PHS share yet, please inform in written (*) to PHS before **April 14th, 2018**, PHS will not deposit as required. Shareholder will receive the certificate of share ownership and go to deposit later.

(*): Application form for non-deposit PHS shares (attached herewith). The signature of the Shareholder on this application must be the same as the one registered to open a securities trading account at PHS.

II. For Foreign Shareholders (Institutional and Individual):

Individuals who are foreign individual and institutional will receive the certificate of share ownership at PHS from **April 20th, 2018**.
