

REMARKABLE POINTS ON THE MARKET

The market was gloomy on Monday as liquidity was still low. Green was maintained in most trading time but the cash flow tended to focus on midcap and penny codes, especially construction, public investment, pork, fertilizer, and sea products. Meanwhile, pillar groups differentiated strongly. Main pressure came from banking. On the contrary, real estate, securities, food and beverage increased slightly. Therefore, main indexes nearly stayed at reference. Foreign trade brought positive signs as they disbursed again although the net buying wasn't too strong.

TECHNICAL POINT OF VIEW

In technical term, VN-Index saw another gain. The volume stayed below 10 and 20-session average, showing that the trade is cautious. Not just that, the index closed below MA20 that dropped, and ADX stayed above 29 and +DI was above +DI, showing that the main trend in short-term is still dropping and this gain might only be within a technical recovery. However, the index stayed above MA5, and RSI stayed on uptrend, showing that the recovery tended to get better and technical recovery might continue with target resistant around 1,170 points (bottom balance level in August). For HNX, HNX-Index saw similar situation. The index also gained and stayed above MA5, and RSI increased to 41, showing that the index continued on technical recovery after the gain on October 2. Therefore, investors might consider taking T+ surfing trades at a low weight. In which, having priority on good-fundamental codes with Q3 growing prospect and is at over selling state.





